

Summary Annual Report for Operating Engineers Health & Welfare Fund

This is a summary of the annual report of the Operating Engineers Health & Welfare Fund, Employer Identification Number 95-6034886, Plan No. 501, for the year ended June 30, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay certain hospital-medical, vision, prescription drug, life, accidental death and dismemberment, and disability benefits incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with Blue Cross of California, Health Plan of Nevada/Sierra Health & Life, Kaiser Foundation Health Plan Inc., Sierra Health and Life Insurance Company, Inc., HCC Life Insurance Company, Delta Dental of California, Safeguard Health Plans, Inc., United Concordia Insurance Company, and United Concordia Dental Plans of California, Inc., to pay certain hospital, medical, vision, accidental death, dental, disability and stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ended June 30, 2018, was \$79,245,812.

Because one is a so called "experienced-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan Year ended June 30, 2018, the premiums paid under such "experience-rated" contract were \$1,727,979 and the total of all benefit claims paid under this experience-rated contract during the Plan Year was \$1,465,193.

Basic Financial Statement

The value of Plan assets after subtracting liabilities of the Plan, was (\$5,391,787) as of June 30, 2018, compared to (\$15,562,507) as of July 1, 2017. During the Plan Year, the Plan experienced an increase in its net assets of \$10,170,720. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan Year, the Plan had total income of \$252,021,334 including employer contributions of \$230,902,381, participant contributions of \$20,373,980, earnings from investments of \$128,290 and other income of \$616,683.

Plan expenses were \$241,850,614. These expenses included \$12,371,928 in administrative expenses and \$229,478,686 in benefits paid to or for participants and beneficiaries.

4. transactions in excess of 5% of the Plan assets;

5. insurance information, including sales commissions paid by insurance carriers.

The charge to cover copying costs does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
