

**SUMMARY ANNUAL REPORT**  
**FOR OPERATING ENGINEERS VACATION-HOLIDAY SAVINGS TRUST**

This is a summary of the annual report of the Operating Engineers Vacation-Holiday Savings Trust ("Trust"), E.I.N. 95-6067144, Plan No. 501, for the year ended June 30, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Trust has committed itself to provide certain vacation-holiday benefits incurred under the terms of the plan.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$4,311,819 as of June 30, 2020, compared to \$4,013,419 as of July 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$298,400. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$45,344,262 including employer contributions of \$44,223,239, recontribution of benefits of \$114,763, earnings from investments of \$915,245 and other income of \$91,015.

Plan expenses were \$45,045,862. These expenses included \$822,623 in administrative expenses and \$44,223,239 in benefits paid to or for participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An independent auditors' report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of the plan assets; and
5. information regarding the common/collective trust in which the plan participates;

The charge to cover copying costs will be \$5.25 for the full annual report, or 25 cents per page for any part thereof.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (100 Corson Street, Suite 100, Pasadena, California 91103) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. **Paperwork Reduction Act Statement**
