SUMMARY ANNUAL REPORT

FOR OPERATING ENGINEERS LOCAL 12 DEFINED CONTRIBUTION TRUST

This is a summary of the annual report of the Operating Engineers Local 12 Defined Contribution Trust ("Trust"), E.I.N. 83-0984282, Plan No. 001, for the year ended June 30, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund or arrangements providing benefits partially through annuity contracts. Plan expenses were \$7,290,651. These expenses included \$765,294 in administrative expenses and \$6,525,357 in benefits paid to participants and beneficiaries. A total of 22,121 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$375,578,248 as of June 30, 2024, compared to \$253,110,075 as of July 1, 2023. During the plan year the plan experienced an increase in its net assets of \$122,468,173. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$129,758,824, including employer contributions of \$104,009,886, rollover contributions of \$272,328, and earnings from investments of \$25,476,610.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (100 Corson Street, Suite 100, Pasadena, California 91103) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
